	Growth Deal	
	CJE stated that the proposition document for GMW has been submitted to both	
	Governments and officers have been working with both Governments on the detail.	
	CJE explained that officers have been working on Project Validation Reviews with	
	both Governments and a Report is currently being drafted. Portfolio Workshops with	
	both Governments have been arranged for this week and in a fortnight's time. CJE stated that it is hoped the Heads of Terms will be agreed in the next few weeks with	
	the full Deal agreed in March 2021.	
	EAG thanked officers for the work undertaken to prepare for the Project Validation	
	Reviews and looks forward to receiving the outcome.	
	Mid Wales RLSP	
	CJE noted that WG have offered funding for the initial set up of the RLSP for Mid	
	Wales and officers have been working on proposals which will be submitted by the	
	end of this month and will be discussed in more detail at the next GMW Board (Joint	
	Committee).	
	EAG stated that she is pleased to hear the progress of the RLSP for Mid Wales.	
	PD asked if there has been a review of the Growth Deal Business Plan in light of the	
	pandemic? CJE explained that the pandemic has been at the front of everyone's	
	minds and the shape of the economy has changed from when the document was	

	developed. Discussions have been had with political leaders and the private sector and the Deal will have to be flexible in terms of changing economic circumstances. CJE stated that the team are also working with WG on the economic response and the Growth Deal is about medium-longer term support there is no indication that this needs to change. CJE explained that projects haven't been agreed as yet and this phase is to set the foundations to allow the region and stakeholders to have a strong	
	say on what the Growth Deal will support to respond to what the economy requires.

	ArthurE stated that the current programme indicates (subject to caveats) that they should be able to deliver phase 1 and be operational in revenue in 2023 and phases two and three in 2024 and 2025. ArthurE stated that there have been positive discussions about opportunities and the need for a dynamic environment for skills.	
	MD stated that the Rail Academy is under their work based learning contract and there are good opportunities to have specialists in this work and to use more enhanced engineering programmes to prepare people for the work.	
	AE asked if other opportunities for the passenger line has been considered? ArthurE stated that the line is there and is in good condition and has been part of similar discussions and similar questions raised over the last 18 months as to what else might materialise in the future in terms of usage.	
	RH stated that it is important to note that there will be extra economic development and tourism opportunities attached to this facility as people will travel and stay in the area to use the facility. ArthurE stated that accommodation will need to be considered as when the site is operational, there will be engineers, academics and researches engaged on the site on a day to day basis, and there are not many alternative accommodation options in the area.	
	ArthurE stated that he will continue to keep the Partnership updated on progress.

	RLIM asked if the team have been in contact with the Aberystwyth University's Centre of Excellence as part of this work. DO stated that discussions have been held.	
	NW asked if the team have been in discussion with the Health Board as more outpatient appointments are taking place online. DO stated that there is a joint Health & Social Care Strategy under the RPB in Powys and an element of that is Digital First and the team have worked closely with the digital lead to ensure plans are aligned. EW asked how the team are going to target members of the community who do not have access to resources to find more information and apply for the Broadband Upgrade Fund? DO stated that they will work with local schemes and have officers on the ground.	
	EAG stated that difficulties were encountered in the past when the Glandyfi exchange wasn't recognised as being in Ceredigion when it was. EAG stated that there is a problem with the definition of a county boundary. GJ confirmed that this is an issue the team are aware of and they are working with Local Government on the issue at present.

	Regional Economic Recovery In Response To Covid 19	
	AW provided an update to Members on WG's response to business support in light of the pandemic, the recovery work that is ongoing and the work to develop the Regional Economic Framework.	
	AW stated that WG made over £1.7billion available to support businesses in Wales to compliment the other UK Gov. schemes. AW stated that work has shown that the package of support has reached businesses who need it to the most. 34% of businesses in Wales have benefited from the support compared to 14% in England and 21% in Scotland. AW stated that business rate grants worth over £758mil have been provided by Local Authorities to eligible businesses in Wales. AW stated that 13,000 businesses have also benefited from the Economic Resilience Fund which has been able to safeguard over 100k jobs. Xxx has offered to support micro and larger businesses. AW stated that work is ongoing with regard to another package of support. AW stated that WG have been responsive to feedback received from businesses has been identified as an area facing difficulty and AW stated that a £5mil package of support will launch from April 2019 to March 2020. A £40mil	

package has also been made available for employers to take on and train new workers to include apprenticeships.

AW informed Members that Counsel General, Jeremy Miles MS, is leading on much of this work for WG. In addition, Ken Skates MS, is also looking at economic recovery in light of the pandemic and the Cabinet have agreed that they are looking at a programme of activities on the principles of social justice, fair worth and environmental sustainability which is embedded in to the Cabinet commitments of People, Place, Green and Digital.

AW informed the Partnership that that they are moving into a phase of engagement on the Regional Economic Framework and this will be co-designed with the region and stakeholders. AW stated that details will be sent to members which will include a number of interactive events throughout the autumn which will help identify common shared priorities that the public, private and voluntary can sign up to.

SH thanked AW for the update and noted that while businesses have been extremely grateful to WG for the business support that has been made available, there is also a need to look at support for the iconic annual Mid Wales events that are going to struggle through any phased opening.

AW stated that she will convey SH's comments back to colleagues in Welsh Government.

• Update on RIIW work programme and OECD events

RG-J provided an update to Members. RG-J explained that she is the Deputy Director for Regional Investment at WG and is working on post-Brexit future regional investment in Wales. RG-J explained that CJE and CM are members of the sub group and a number of Councillors are part of the external steering group chaired by Huw Irranca-Davies MS.

In addition to the steering group, RG-J stated that they are working closely with a Ministerial Group comprising the Counsel General, Minister for Economy & Transport, Minister for Housing & Local Government and the Minister for Finance. RG-J explained that meetings have been held during August and September and detailed proposals for future regional investment will be presented to Cabinet members. RG-J stated that analysis from a consultation held with stakeholders from February to June will be published in the coming weeks. RG-J stated that it was a fantastic consultation response and the proposals will need to take account of the economic recovery due to the pandemic.

RG-J explained that the Counsel General will be meeting with the Secretary of State for Wales and the Minister for Housing and Local Government tomorrow afternoon to discuss the UK Gov. position and the UK Shared Prosperity Fund and what that will mean in terms of the relationship between WG, UK. Gov and stakeholders.

RG-J stated that the aim is to work closely as the four regions of Wales to have investment as best we can in Wales.

RG-J stated the OECD Report was launched last week. RG-J mentioned that CJE spoke at an OECD event last week which went well. RG-J explained that the OECD worked closely with stakeholders on the Report. RG-J stated that they will be having more detailed discussions with each region and the Mid Wales event will be held on Tuesday, 29th September (details shared by CM) to discuss the regional needs and priorities and what will be needed from the OECD and WG to deliver those.
