## **Powys**

Allocated employment sites have been grouped into categories that reflect the nature of the site and the potential future uses. These categories, which reflect best practice and current thinking in adjoining authorities, are:

- **Prestige**: Strategically located sites in the regional context offering medium to large scale employment opportunities for primarily B1 Uses (such as offices, research and development centres for products and processes and light industry) and characterised by a high-quality environment.
- **High Quality**: Smaller sites of regional significance offering small to medium sized employment opportunities for B1, B2 and B8 Uses in high quality surroundings that are well positioned in relation to the County's main road and transport infrastructure.
- **Local**: Sites for B1, B2 and B8 Uses providing a varied industrial and / or employment setting with minimised visual impact (for example, screening) yet located within close proximity to the main road and transport infrastructure as well as centres of population. These sites primarily serve a local market and may include local office developments.
- **Mixed Use**: Sites where employment led mixed use proposals are supported in order to stimulate private sector investment and development.

## Ceredigion

The LDP meets the recommendation made by the DTZ Assessment which indicated that a range of employment sites need to be facilitated through the LDP, through allocations and through permissive policies. This range includes:

- **Prestige**: A strategically located site in its regional context offering medium to large scale employment opportunities and characterised by its high quality environment.
- **High Quality**: Smaller site of regional significance offering either small or medium scale employment opportunities in attractive surroundings that are well positioned in relation to the County's main road network.
- **Local**: Providing a more varied industrial image and setting yet with close proximity to the County's main road network adjacent to existing settlements. Likely to serve a local market and may include small scale local office developments.
- **Neighbourhood**: Typically suited to a smaller or local operation and located in a very mixed environment within or in close proximity to existing built up areas or small towns.
